Gary Martin, Executive Director of Access Sacramento reported they are experiencing the highest membership ever with 450 members; KUBU is now in its 5th year of operations; and awards will be handed out at the 19th Annual A *Place Called Sacramento* film festival scheduled for October 6, 2018.

David Lowe, President of KVIE congratulated Director Sarah Pollo on being nominated for 40 Under 40 by the Sacramento Business Journal, which celebrates 40 of the region's brightest and most talented upand-comers in 2018. A video of KVIE's digital studios was shown.

Philip Arndt, Comcast's Director of Government Affairs announced the Comcast Internet Essentials Program is a great success, connecting more than 6 million low-income Americans to high-speed, low-cost Internet at home.
